Ko Taku Reo Preschool:





Rationale

All children and adults in the pre-school environment shall be kept safe from harm. This is achieved through regular hazard identification and review of accidents within the premises.

Staff will determine whether the injury is minor or serious by following the definitions outlined below.

Standard injury	Requires first aid attention but the child does not need to leave the pre-school ground to seek further medical	
	advice.	
Serious injury	1. Injury (including that caused by gradual process) or	
	disease which causes:	
	a. permanent loss of bodily function; or	
	b. temporary severe loss of bodily function	
	(including any harm causing the person to	
	be unable to perform their normal duties for	
	more than 7 calendar days); or	
	2. Amputation or surgical removal of body part; or	
	3. Loss of consciousness, or acute illness requiring	
	treatment by a medical practitioner from:	
	a. lack of oxygen; or	
	b. absorption, inhalation, or ingestion of any substance; or	
	c. contact with any energy source; or	
	d. a fall or other physical impact; or	
	4. Any physical or mental harm that requires hospital	
	admission, surgery, or treatment by a medical	
	practitioner who is a registered specialist operating	
	within their scope of practice.	

When an accident occurs

When a **child** is involved in an accident, staff will use the following procedures:

In the event of a minor injury, qualified first aid staff will:

- attend to the child's injury and comfort the child.
 - o Protect themselves by wearing gloves if blood is present.
 - Place any items with blood into a plastic doubled bag before being placed in the rubbish bin.
- Provide appropriate first aid.
- Record in Playground app



In the event of a **serious injury**, qualified first aid staff will:

- Attend to the child's injury. Staff will:
 - o Protect themselves by wearing gloves if blood is present and place any items with blood into a plastic doubled bag before being placed in the rubbish bin.
 - o Provide appropriate first aid.
 - Have the option of attending the medical centre across the road to seek medical advice or call an ambulance.
- Contact the parents/guardian at the first possible appropriate time but without delay.
- Record in Playground app
- In the event of a serious accident notification of the incident must be reported to Worksafe New Zealand and the Ministry of Education within 7 days using the contact details provided.

When an **adult** is involved in an accident leading to a near miss or serious harm, staff will use the following procedure:

- Attend to the adult's first aid needs.
- Protect themselves by wearing gloves if blood is present.
- The medical centre across the road can be used to seek medical advice or call an ambulance.
- If the adult is able, they will complete the 'Health and Safety Accident/Injury Notification'. If the person is unable to do this themselves, a witness to the incident will complete the form.
- An injury and incident investigation will be completed to identify any hazards and actions required (see the Incident and injury investigation flowchart appendix b)
- A copy will be given to Human Resources and a copy kept in the Health and Safety folder.
- In the event of a serious accident, notification of the incident must be reported to Worksafe New Zealand within 7 days using the contact details provided.

Accident register

All incidents of children will be recorded in the Playground app and kept indefinitely. A report will be generated on the Playground/Xplor platform and reviewed at the end of every term or as appropriate. The aim of review is to:

- provide recommendations.
- determine any patterns and reduce risk of any accident.
