

# PRIVACY POLICY

# Our privacy commitment

We are committed to being open and transparent about how we manage your and your child's personal information.

Our Privacy Policy aims to communicate, in the clearest way possible, how we treat your and your child's personal information. We encourage you to read this Privacy Policy to help you make informed decisions about sharing your and your child's personal information with us.

At Ko Taku Reo we have a few fundamental principles:

- We will **always** collect, store, use and disclose personal information in accordance with all applicable privacy laws. However, we have also put in place this Privacy Policy to protect personal information you submit or we collect.
- We will **only** use your and your child's personal information when it is necessary for us to deliver you and your child our services or perform other necessary business functions and activities.
- We will **not** use or disclose your or your child's personal information for purposes unrelated to our business activities and the services we provide, unless we first obtain your consent.

# **Privacy Policy**

This Privacy Policy sets out how we comply with our privacy obligations under applicable laws. New Zealand's privacy and healthcare laws regulate how we may collect, store, use and disclose personal information. We are bound by the requirements of those laws, which regulate how we may collect, store, use and disclose your and your child's personal information. Those laws also specify other requirements, such as how individuals may access, correct and delete information held about them. When we say personal information, we mean identifiable information about you and/or your child, such as names, emails, addresses, telephone numbers, school history and so on. When we say sensitive information, we mean a special category of personal information, like health information. In this Privacy Policy "we", "us" and "our" all refer to Ko Taku Reo, which has been the national organisation for deaf education in New Zealand since the merging of Kelston and Van Asch Deaf Education Centres in 2020.

### **Your Consent**

As New Zealand's provider of education services for Deaf and hard of hearing children, Ko Taku Reo provides specialist schools, facilities, campuses and related deaf educational services (Services). In order to provide your child with our Services, Ko Taku Reo relies on the collection of personal information submitted by you or with your authority.

By using our Services or providing your and your child's personal information to us, you consent to our collection, storage, use and disclosure of your and your child's personal information in accordance with this Privacy Policy.

## Changes to this privacy policy

We may amend the terms of this Privacy Policy from time to time and will notify you of any changes by posting an updated version on our website or by sending you a notice via email. It is your responsibility to check this Privacy Policy periodically for changes, and to keep your email address with us current.

Your and your child's continued use of our Services following notification of any changes to this Privacy Policy constitutes acceptance of those changes. If you do not agree with any aspect of the updated Privacy Policy, you must immediately cease all use of our Services.

### What information do we collect?

Information you provide to us directly: Our usual practice is to collect personal information directly from you, when you complete any form, or otherwise register to use any of our Services on behalf of your child, or provide any other information in connection with your and your child's use of our Services. A few examples include:

- name, gender and ethnicity to identify support that reflects the child's identity, language and culture
- date of birth and year level, to identify support that is appropriate to their age
- photographs of your child
- your details as the child's parent/guardian
- national student number
- the type of support needed
- health information: any health issue, disability or learning difficulty that means a child needs particular types of support
- information about services and support they are already receiving

You can always choose not to provide your and your child's personal information to Ko Taku Reo, but it may mean that we are unable to provide you and your child with the Services.

Sensitive information: We may collect or obtain sensitive information (such as health information, and audiological and language information (e.g. audiograms, reports, communications)) directly from you or from other sources (for example, your child's previous school or deaf education provider, audiologists, or speech language therapists) where you have authorised us to do so.

You can choose not to authorise us to collect this information, but it may mean that we are unable to provide you and your child with the Services.

Other Information we get from third parties: We may collect or obtain personal information from third parties authorised by you (e.g. the Ministry of Education) for the purpose of providing a timely, appropriate and effective service that results in a seamless transition between our services including the following specific information:

- In the event that your child moves school, and we are unable to determine which school they have moved to, we may use your child's National Student Number to confirm which school your child is currently enrolled in. This is achieved by locating this information using Ministry of Education data systems including accessing the ENROL database.
- Details of assistive technology used by the learner and language assessment data may be obtained from the Ministry of Education Advisors of Deaf Children.

You can choose not to authorise us to collect this information, but it may mean that we are unable to provide you and your child with the Services.

Information we collect automatically: We may collect personal information about you automatically when you visit our websites, like your IP address and device type, or use our Services, like CCTV security cameras on our premises. Some of this information may be collected using cookies and similar tracking technologies.

Information we create in the performance of the Services: We may also create or obtain personal information about your and your child's interactions with us. Some of this information may be confidential to us.

Information you make public: We may collect or obtain your and your child's personal information that you manifestly choose to make public, including via online channels such as social media (e.g. LinkedIn, Facebook etc.)

### How is personal information processed?

Where we collect personal information or sensitive information, we will only process it:

- to perform a contract with you or to provide the Services to you (or any related services you may request); or
- where we have legitimate interests to process the personal information or sensitive information and these interests are not overridden by your rights; or
- in accordance with a legal obligation; or
- where we have your consent.

## Why we collect personal information?

We collect and use personal information or sensitive information for the following purposes:

- to communicate with you;
- to publish personal information (such as names, photographs, school work) in our newsletters, on our school website and online channels (such as school/class blogs, social media e.g. Facebook or YouTube pages);
- to process and administer the Services (including storing personal information in our Student Management System) and to help us develop, improve, manage, administer and facilitate our Services and educational operations;
- to process your and your child's personal information for our internal purposes (such as record keeping, database management, training, obtaining public funding);
- to verify your child's enrolment identity and application/enrolment details;
- to assist with the resolution of any issues relating to you or the Services;
- to liaise with the Ministry of Education for the purposes of fulfilling our obligations under our contract(s) with the Ministry of Education;
- to provide personal information and health information about you where validly requested to do so under the Privacy Act or any Code issued under that Act:
- to provide related service providers with your personal information and health information (including your Covid-19 vaccination status) in connection with providing the Services;
- to ensure the safety and security of our premises in connection with providing the Services (for example in the use of CCTV surveillance);
- to provide any information and records regarding you to any person properly appointed to audit our Services; and
- to comply with all laws and regulations in all applicable jurisdictions.

By using the Services, you consent to your personal information being collected, stored, used and disclosed in this way and for any other use you authorise. Ko Taku Reo will only use your personal information for purposes described in this Privacy Policy, or with your consent.

# In what very limited circumstances might we disclose your personal information?

We do not sell, trade, rent or otherwise provide your personal information to others without your consent.

We will only disclose your personal information outside Ko Taku Reo, including to:

 education facilities where we provide our Services, appropriate education, health and welfare authorities and to the Ministry of Education; and • the Ministry of Health and other participant education providers in the school/kura/early learning service group we are part of,

if it is necessary and appropriate to:

- facilitate the purpose for which your personal information was collected pursuant to this Privacy Policy and your consent form, including the provision of the Services, or a directly related purpose
- identify children and young people who might need additional learning support
- ensure that the adults who work with children (such as teachers or teacher aides) have the skills and resources they need to support them
- decide what additional learning support would help children and young people, whether individually or in groups.

Only those people who need access to the Ministry of Health's register for the purposes explained above will have access to your and your child's personal information. By way of example, they may include school staff members with responsibility for learning support (e.g., learning support staff and associated administration staff), or resource teachers of the Deaf.

We will seek your specific agreement before your or your child's personal information is disclosed to other organisations in support of your child's learning needs. We will not otherwise disclose personal information unless such disclosure is authorised by you or required by law.

### International data transfers

In connection with providing the Services, you accept that your and your child's personal information may be collected or held in New Zealand and be shared with, disclosed to recipients in, or transferred to, or processed or stored in, countries other than New Zealand.

There may be differences between New Zealand's privacy laws and those of the overseas locations in which personal information is located. However, your personal information will only be provided by us to recipients outside New Zealand if we have reasonable grounds to believe that:

- (a) the recipient is subject to New Zealand privacy laws;
- (b) the recipient is subject to privacy laws in their country that offer comparable safeguards to those under New Zealand's privacy laws;
- (c) the recipient agrees contractually to protect the information in a way that provides comparable safeguards to those under New Zealand privacy laws; or
- (d) we have your permission.

### Storage and security

We are committed to protecting the security of your and your child's

personal information and we take reasonable organisational and technical security measures that are designed to protect it from unauthorised access, modification or disclosure.

### What about links to other websites?

Our website may contain links to other websites that are not under our control. These websites may use cookies. It is the responsibility of those third parties to collect appropriate consents from you in order to permit their own cookies (to the extent this is required by law) and to inform you about the cookies they use. You should check the privacy policy on all third-party websites to ensure you are comfortable with their privacy practices and use of any third-party cookies.

We have no responsibility for linked websites and provide them solely for your information and convenience. We specifically disclaim responsibility for their content, privacy practices and terms of use, and we make no endorsements, representations or warranties about their accuracy, content or thoroughness. Your disclosure of personal information to third party websites is at your own risk.

### Email, text and telephone communications

We are committed to full compliance with the Unsolicited Electronic Messages Act 2007.

By subscribing to emails and/or text communications, or otherwise providing your email address and/or mobile number, you consent to receiving emails and/or texts (as the case may be) which promote and market our products and services, or the products and services of others, from time to time.

You can unsubscribe from our email communications and/or text communications at any time by clicking the "Unsubscribe" link in any promotional or marketing email or text received or by emailing <a href="mailto:privacy.officer@kotakureo.school.nz">privacy.officer@kotakureo.school.nz</a>.

Once you have unsubscribed from the email or text communications, you will be removed from the corresponding marketing list as soon as is reasonably practicable.

# How can you access or correct personal information?

It is your responsibility to ensure that the personal information you provide is accurate, complete and up to date.

You may request access to the information we hold about you, or request that we update or correct any personal information we hold about you, or ask us to restrict or cease processing your and your child's personal information or even delete your personal information, by setting out your request in writing and sending it to us at

privacy.officer@kotakureo.school.nz.

We will review your request as soon as reasonably practicable to comply with our legal obligations. If we are unable to give you access to the information you have requested, we will give you reasons for this decision when we respond to your request.

## **Privacy Officer**

We take your concerns seriously.
